PURPOSE: To provide a scholarship, in the name of Juli A. McDaniel, to a deserving St. Anthony High School graduating senior intending to pursue a post-high secondary education. Juli McDaniel graduated from St. Anthony Village High School in 1975, at 16 years old. She went on to graduate from Metro State University and receive an BA from the Kellogg School of Management (at Northwestern). In pursuing her career, she lived in Kansas City, MO, Manhattan Beach, CA and Chicago, IL, where she reached the level of Chief Procurement Officer for Sara Lee Corp. In 2002 she left the corporate world and focused her energy on the things that inspired her most: family, friends, music and travel. Juli passed away from cancer in May, 2009.

AWARD COMPONENTS: A \$3,000 scholarship will be awarded to one student selected by the Juli A. McDaniel Memorial Foundation Scholarship Committee. The scholarship funds will be awarded to the student upon evidence of acceptance and registration in an accredited post-secondary institution.
